The purpose of this SGM is to pass, by a special resolution, a new set of Rules (Constitution) to replace the existing Constitution which requires that "Any alteration to the constitution shall be decided by a two thirds majority of votes". Under the Associations Incorporations Act 1985 "an alteration to the rules of an incorporated association comes into force at the time that the alteration is passed". Assuming that the Draft Constitution (or set of Rules) is/are accepted at this SGM then the ensuing AGM can be held in accordance with the new Rules.

The new Rules must be registered with Consumer and Business Services within one (1) month of the special resolution accepting the new rules or face a fine of \$1,250.
