Section 2.

2. DEFINITIONS

Re-word the definition of the Watervale Community to include non-residents of Watervale who have interests in Watervale and would be eligible to become members of the WCA and /or members of the WCA Board viz;

"Watervale Community" means the residents of the Watervale District and individuals who work, have business interests, are members of sporting clubs or otherwise have an active involvement in the Watervale District and support the Objects of the Association.

Re-name the previous Watervale Community definition with a definition for the Watervale District viz;

"Watervale District" means the township and environs of Watervale in the South Australian Local Government Area of Clare and Gilbert Valleys Council area within Post Code 5452.

5.1 Members

Reword the Members criteria to reflect the definitions of the Watervale Community and the Watervale District viz;

a. Any person over 18 years of age who is a resident of the Watervale District or has an active involvement in the Watervale Community and who supports the objectives and purposes of the association shall be eligible to be a member of the Association
