3. Special Discussion- Watervale Institute- Judy Giles CGVC

Agenda was put forward to Council to sell the institute to support the Mount Horrocks society to repair a roof on the cottage.

Council has offered to support MHHS to digitalise their documents and information.

Currently the Institute is only open on a needs basis.

There are two different issues- the building and then items that are being stored in it.

Katherine has offered the use of the vault at Saddleworth to store the photos and other items which the MHHS can have open access too. It will also ensure that they don't start to deteriorate.

Digital Honour Boards can be used to display the information for events.

Helen MacDonald CEO would like to know what community think in relation to the building.

It is no longer on the State Heritage list.

This will ensure the development of a digitalised collection which will professionally preserve and conserve the region's history for future generations and will improve access for the general public.
