2. Business Arising:

- 2.1 Community Social Nights: The last event was 1 March successful. Louise Haines was putting together Bahn Mi's which potentially helped to bring the crowds in. Brian Rogers has been in touch to book the Vale for the next one, 26 April. This is the night after Anzac Day. Susan has sent a message to Brian to see if they want to change it to Anzac Day.
- 2.2 Defib pad replacement- Email has been sent to Bowling Club seeking invoice for reimbursement,
- 2.3 Playground development: Shannon has been trying to get in touch with Judy Giles. Heidi Hodge is looking into applying for a grant that would combine both a new play area and the grandstand refurbishments needed before cricket will take the lease on.

2.4 Grants: Solar Panel Quotes – Shannon has been getting quotes, sun energy 13 kw/10kw battery - \$23454. There are opportunities for finance which would be approximately the same as what we are currently paying in electricity. We will look into grants first though.

2.5 Grandstand Upgrade: The cricket club are still holding off until the refurbishments are completed before signing a lease.

- 5.1.1 Bookings are a bit light on going forward. We might need to look at some promotion if this continues.
- 5.1.2 Maintenance- LPG Gas Supply. Shannon has been looking into an alternative gas supplier. Elgas have quoted \$1 per Litre rental versus the current \$1.70 we are paying with Origin. We will have a rental service for the 210 cylinder of \$150. Shannon Parker proposed we accept this quote. Seconded by Steve Hadley. All voted in favour
- 5.1.3 Steve Hadley is going to get a quote on spider spraying. We also need to reinstall rat baits.
- 5.1.4 Business Plan- This is difficult to consider as we are not fully aware of our financial situation. The Community drinks are helping to bring in some money.
- 5.1.5 Promotion- need to think about this.
